

# Florida KidCare Title XXI Enrollment and Major Program Changes

**July 2002 Enrollment = 264,278**

**July 2003 Enrollment = 326,755**

July 2003 Program Changes:

- “No Growth” budget enacted
- Program over-enrolled, wait list started
- No Title XIX to Title XXI transfers
- Federal and state funding for Florida KidCare Outreach eliminated

**October 2003 Enrollment = 322,997**

December 2003 Program Changes:

- 6-month cancellation for premium non-payment
- No reinstatements for breaks in coverage
- Jan. 04: Only CMSN accepts Medicaid to Title XXI transfers (ended Mar. 04)
- Mar. 04: Legislation enacted — wait list funded, other program changes

**January 2004 Enrollment = 315,222**

**April 2004 Enrollment = 336,689**

April 2004 Program Changes:

- Begin enrolling Title XXI Wait List

**July 2004 Enrollment = 331,281**

July 2004 Program Changes:

- New income documentation & access to employer health insurance requirements (delayed due to hurricanes)
- New enrollees accepted only during open enrollment
- Loss of Medicaid for over-income eligible to apply outside of open enrollment, 7/1/04

Fall 2004 Program Changes:

- Premium non-payment penalty reverts to 60 days
- Reinstatements allowed if in the data system before 3/12/04
- *Hurricane Relief Provisions*: No disenrollments for failure to provide renewal documents or failure to pay premiums, credits for those who did pay (3 months)

**October 2004 Enrollment = 323,262**

December 2004 Program Changes:

- Open enrollment announced
- Disenrollments for renewal non-compliance and unpaid premiums implemented
- Legislature reduced income documentation requirements

**January 2005 Enrollment = 252,209**

January 2005 Program Changes:

- Open enrollment Jan. 1-30, 2005;
- Applications processed, children start

**April 2005 Enrollment = 220,533**

**July 2005 Enrollment = 202,433**

July 2005 Program Changes:

- Year-round open enrollment reinstated; application valid for 120 days

August 2005 Program Changes:

- Back-to-School campaign, post cards

**October 2005 Enrollment = 202,615**

**January 2006 Enrollment = 186,080**

**April 2006 Enrollment = 189,726**

**July 2006 Enrollment = 196,674**

**October 2006 Enrollment = 195,826**

Winter 2006 Program Changes:

- Marketing campaign, online application

**January 2007 Enrollment = 204,214**

**April 2007 Enrollment = 214,988**

**July 2007 Enrollment = 224,175**

Mid-2007 Program Changes:

- Back-to-School outreach campaign
- 5,000 additional slots appropriated in legislative Special Session

**October 2007 Enrollment = 226,302**

**January 2008 Enrollment = 230,567**

**April 2008 Enrollment = 228,596**

May 2008 Program Change: ACS takes over as KidCare third party administrator

June 2008 to March 2009 Program Change: MediKids, Healthy Kids, & CMS Network enrollment subject to change after further reconciliation is complete

**July 2008 Enrollment = 225,069\***

July 2008 Program Change: EDS takes over as Medicaid fiscal agent

Fall 2008 Program Change: Back-to-School/fall statewide outreach campaign

**October 2008 Enrollment = 208,761\***

November 2008 to January 2009 Program Change: Temporary suspension of disenrollment for certain cancellation reasons

**January 2009 Enrollment = 218,192\***

**April 2009 Enrollment = 220,614\***

July 2009 Program Change: Administrative simplification implementation (SB 918)

**July 2009 Enrollment = 228,704\***

FY 2009-2010 Enrollment Target: 244,578

**October 2009 Enrollment = 230,601**
